

**4** Enter your nine-digit Juror Participant Number located on your summons, first three letters of your last name, date of birth (i.e. 1956), and click the Login button

### Login

For identifying information, please enter the following:

- Enter your nine (9) digit **Juror Participant Number** found on your summons (located below the phone no. to call).
- Enter the first **three (3) letters** of your last name.
- Enter your **Date of Birth**. Please enter the birth year as four digits (i.e. 1956)

**It will take approximately (ten) 10 minutes to complete the Juror Qualification (first) Questionnaire. After completing the Juror Qualification Questionnaire, you are asked to complete the Prospective Juror (second) Questionnaire.**

**All questions on the Juror Qualification Questionnaire that are marked with a red asterisk are required.**

**Your responses will not be retained if you exit before completion.**

### Prospective Juror (second) Questionnaire

To avoid questions being asked in open court during jury selection and to shorten the jury selection process, you are asked to complete the Prospective Juror (second) Questionnaire.

Continue

- If you have a hardship, the court may grant you a one-time postponement of your jury service. The request for a postponement is located on this questionnaire.
- After you have completed the Questionnaire, you will once again have the opportunity to review and edit your answers. Please be sure to click the **Confirm button** or your answers will not be saved.
- If you entered your email address, you will receive confirmation from the court that your Questionnaire was completed.

## FREQUENTLY ASKED QUESTIONS



### How do I know that the court's website is secure?

The court follows current best practices for database and server security, maintained by highly-skilled Information Technology court staff, and supported by a dedicated national network security group.

### What if I don't have a computer?

The court understands that not all prospective jurors have access to a computer. You may wish to use your local library's computer terminals to access our website. The court also makes computers available to the public if it is convenient for you to visit us at our Pocatello location; however, if none of these options are available to you, and you require paper copies, please call 1-844-868-6769 (toll free).
