

ANDREA GEORGE

Andrea George is the Executive Director of the Federal Defenders of the Eastern District of Washington and Idaho. From 1989 to 2011, she was an Assistant Federal Defender for the District of Minnesota and held the position of Senior Litigator from 2005 to 2011. Ms. George received her B.A. degree from the University of Wisconsin - Madison, 1984, and her J.D. degree from Hamline University School of Law - St. Paul, 1989. She is on the faculty of the National Criminal Defense College, Macon, GA, the Wisconsin Trial Academy, and the Trial Academy sponsored by the Office of the Alternate Defense Counsel, Denver, CO. She also speaks nationally for the Federal Judicial Center, the Office of Defender Services, Washington, D.C., and various other defender organizations.

GEOFFREY HANSEN

Geoff Hansen received his B.A. in political science with distinction from Stanford University in 1974. He attended law school at Boalt Hall and received his J.D. in 1978. He spent the next three years at the Ninth Circuit, where he was a court law clerk, a division chief in the staff attorney's office, and finally the senior motions attorney for criminal matters. In 1982 Geoff left the Ninth Circuit and began working as an Assistant Federal Public Defender in San Francisco. In 1988 he was appointed Chief Assistant of the office, a position he presently maintains. He has been an adjunct professor at Hastings since 1980, where he has taught legal research and writing, moot court, criminal law, trial advocacy, and trial objections. He also coaches the Hastings Trial Team. He has been a faculty member at seminars and training programs for federal public and community defenders, private criminal defense attorneys, and students at various universities. He is the former President of the Criminal Trial Lawyers Association of Northern California, and in 2012 the National Association of Federal Defenders awarded him the Terrence MacCarthy Award for his lifetime commitment to indigent defense. Geoff has authored or co-authored case outlines on the federal three strikes law, technology in the courtroom, defending internet crimes, and the federal detention act.
